Pursuant to a congressional request, GAO reviewed a random sample of 101 Multiple Award Schedule orders exceeding 25, 000 for federal information processing resources at six selected procurement offices, focusing on whether the procurement offices complied with statutory and regulatory procurement requirements. GAO found that: (1) although the agencies generally complied with the Federal Information Resources Management Regulation (FIRMR) requirement to place notices in the Commerce Business Daily (CBD) regarding proposed Information Resources Management Service (IRMS) schedule orders expected to exceed 50, 000, they did not synopsize orders with expected values of 25, 001 to 50, 000, as required by statute; (2) of the 101 sample orders valued at more than 25, 000, 36 had synopses published in CBD prior to award; (3) procurement offices CBD notices were often unnecessarily restrictive of competition; (4) 13 of the 27 notices did not describe the essential characteristics of the agency's federal information processing requirements so that suppliers of alternative products would know what would be acceptable to the agency; (5) 12 of the remaining 14 notices did not cite the applicable reason for limiting competition although the contract file documentation provided a justification for other than full and open competition; (6) most of the 36 notices generated few or no responses from suppliers, and when suppliers did respond they generally offered non-schedule prices for the products; (7) in all 36 cases, the procurement offices purchased the manufacturers product identified in the notice and in only one of those cases did the orders go to a supplier other than the one identified; and (8) in 6 of the 12 notices with responses, suppliers offered commercial open-market prices for federal information processing items that were...
